

Meeting of the Bristol and District Lady Golfers' Alliance

1. Minutes of the last meeting held on Friday 5th September 2025.

3. AGM update for those who were absent.

Stephanie went through the details of the AGM.

The membership was concerned with the change in the ruling of 7.4 and it was agreed we would revisit this for amendment to the rules in November 2026.

Rule 7.4: The reserved tee time for the seven matches shall be 45 minutes from start of play. Team sheets shall be agreed, prior to the commencement of the match, after that no substitutions will be allowed. **Any player arriving after the 45-minute reserved tee time will forfeit her match and a penalty point will be deducted for not fielding a full team.**

Agreed that this should be amended to "**Any player arriving after the 45-minute reserved tee time without a justifiable reason the decision will be at the discretion of the BDLGA Committee.**"
