**1. HON TREASURER**

She remarked that bank interest was a little higher than last year, and only one cup had to be repaired this year at a cost of £54. There was extra cost to the Harper Salver but this was due to enough golf balls being purchased for three years. The prize money for the Harper Salver remained the same. The accounts were accepted.

**2. HON SECRETARY REPORT**

Joy Ball reported that the first Division was won by Bristol & Clifton with 124 points followed by Henbury with 94 points, Shirehampton and Lansdown drop to the 2<sup>nd</sup> Division. Three people with 18 points Clare Page and Jane Bell of Bristol & Clifton and Helen Potts of Bath shared the Osborne cup.

The 2<sup>nd</sup> Division winners were Weston super Mare with 112 points with Bristol & Clifton B team 2<sup>nd</sup> with 106. Both these teams go up to Division 1 and the Rules of the Alliance will apply to Bristol & Clifton GC. Bath B and Orchardleigh are relegated. Dorothy Bastable won the Trill cup for the 2<sup>nd</sup> time with 19 points.

Wells won Division 3 with another good score of 126 points having come into the Division only last year. They are certainly a rising club. The 2<sup>nd</sup> team Henbury B with 91 points. These 2 clubs go into Division 2. Filton and Clevedon A drop to the 4<sup>th</sup> Division. Angie Seal of Wells won the

Tracy Park Cup with 18 points.

In the 4<sup>th</sup> Division The Park won with 108 points followed by Knowle with 105, both these teams go into 3<sup>rd</sup> Division. Chipping Sodbury and Saltford B drop to Division 5 on a count back.

- 10 Presentation of Trophies**  
The Chairman presented the trophies and reminded clubs that they have to engrave the cups themselves
- 11** The Chairman formerly closed the AGM and thanked the committee for their hard work. She then invited informal discussion.
- 12** Burnham & Berrow raised the point that they needed clarification on the rules when ladies changed handicap the day before a match. Quoting that it seemed unfair that a member who may have taken a day off work to play was suddenly not required. She requested that maybe the availability of players 7 days before a match be “adhered to”  
Weston Super Mare agreed with Burnham & Berrow over the difficulties with ever changing handicaps.  
Wells stated they had a “Squad meeting” at the beginning of the season and discussed “unavailability to play” when handicaps changed at the last moment.  
Mendip said that any player could always make herself unavailable.  
The Chairman reminded ladies of Rule 3 “v” about availability and the Committee could not make a ruling based on timings, but that clubs should interpret the word “availability” within the rules.  
Burnham & Berrow requested that the Rules 3 “v” be rewritten.  
The Chairman took note of this request.
- 12** The Chairman reminded Lady Captains to read and circulate minutes of BDLGA meetings as there is important information contained in them.  
She reminded ladies to try to persuade Club Secretaries to give a reasonable amount of empty tee time before Alliance Matches.  
She referred the Lady Captains to the need to adhere to the time scale for E Mailing their Match Results, and asked outgoing Lady Captains to brief the new Captains accordingly.

Bristol & Clifton said they were thrilled to win the Alliance league for the first time and thanked the BDLGA committee on behalf of the ladies present for their hard work.
